





### The Moors at Arne Project

### **Summary of feedback 2017 Consultation**

Thank you for attending the stakeholder meeting / public drop-in session on the Moors at Arne project held on the 3 October 2017 in the Town Hall in Wareham and the meeting organised by Arne Parish Council on the 31 October in Furzebrook Village Hall. Both meetings and the exhibition were well attended and a variety of thoughts were shared both on the day and in feedback since the events. The consultation period ran from 3 October until the 30 November. This document provides a summary of the collated feedback forms received during and since the events.

As the scheme progresses we will continue to provide opportunities for the local community to see how the project is progressing and to provide us with further feedback. We anticipate that our next stakeholder meeting and public event will be held in the summer of 2018, once we have the results of the investigations carried out over the winter of 2017/18. # Consultation

At the stakeholder meeting and public drop-in session, we introduced the project and the partners involved. We provided context for the project, spoke about current flood risk, why a coastal change project is needed and the options being considered.

## **Analysis**

The stakeholder meeting for consultees was attended by 19 people and 106 attended the public exhibition held at Wareham Town Hall, a meeting for statutory consultees was also held on the 18 September, to which 9 attended. In addition to this, the project team attended a meeting held on the 31 October in Furzebrook Village Hall, organised by Arne Parish Council, over 150 members of the local community attended and the project team delivered a presentation and answered questions on the scheme. Wareham Town Trust also invited the project to present to one of their meetings, which we did on 14 November.

Feedback was provided via feedback forms completed at the events and sent via email to the project email address: <a href="mailto:themoorsatarne@environment-agency.gov.uk">themoorsatarne@environment-agency.gov.uk</a>, a total of 52 feedback forms were received.
