Proposal:

To operate a small, eco-friendly campsite between the months of April and October-limited to a maximum of 10 camping pitches. Campervans and motorhomes will be permitted - up to a maximum of five.

Club Officers have undertaken a full inspection of the site and confirm that it meets the Club's criteria - and can therefore be considered for certification.

A site plan is attached for your attention. The boundary of the land held by the applicant is outlined in blue and the area of the proposed Certificated Site is outlined in red. Please note the farm's total holding is 400 acres, of which only a portion is shown on the attached map.
