

# Minutes of the Meeting of Arne Parish Council held on Thursday 21<sup>st</sup> July 2022 at 7pm at Stoborough Village Hall.

Present: All councillors except Cllr John Ives.

Chair: Cllr S Cranshaw

In the absence, through illness, of our Clerk, Cllr Patrick took the minutes.

Also present: Cllr B Ezzard (DC) Ms Catherine Ferrugia (EA) Mr Ian Alexander(NE) Mr Dante Munns (RSPB) together with 15 members of the public.

## Public Participation

As 2 items on the agenda attracted particular public interest, they were dealt with first.

### The Moors at Arne Project.

The planning application has finally been submitted. 5 volumes of documents were presented to APC by the Environment Agency and the application should be available online early next week. While the time for response is normally 6 weeks, Cllr Ezzard advised that given current delays it might be as long as 12 weeks. Mr Alexander supplied additional notes on construction traffic FAQ.

The application by Knoll Farm, Soldiers Road for a Certificate of Lawfulness for a change of use from agriculture to camping and ancillary music festivals was strongly challenged. Members of the public present were advised to contact DC directly with their evidence as APC has no special role in the process. Mr Richard Brown produced pictures from Google Earth showing the land over a period of years in agricultural use. Mr Ian Alexander (Natural England) advised that “continuously” in the application does not carry its ordinary meaning but instead refers to use beyond the 28 days normally allowed for camping.

It was further suggested that a group be set up to monitor on how many days camping actually takes place.

Cllr Bessant asked that Dorset Highways be requested to cut back the overhanging branches that are obstructing the view over Corfe Road at the approach to the Stoborough roundabout. A parishioner had asked that the right of way path from Old Furzebrook Road to Corfe Road needed to be trimmed back as there were places that were encroaching the path.

Similarly Cllr Church asked that the long grass be cut back in Nutcrack Lane .

The Chair asked that the parish council now approach the independent expert hydrologist to read the Moors Planning Application, with a view to answering the question-

Is there anything here that would give rise to concern for residents of this parish?

This was unanimously agreed.
